In developing this plan, the district included input received from community members during the development of the LCAP and the Education Learning Opportunities Grant (ELOG) Plan. The district collaborated with the board of trustees, parents, teachers, and school staff and involved them in planning through the Return to School teams in 2020-21 and ongoing feedback sessions. Input from parents, staff, and students at feedback sessions in March 2021 was also considered in the development of the LCAP, ELOG, as well as the ESSER III Expenditure Plan.

A description of how the development of the plan was influenced by community input.

During the three months from June 1, 2020 to September 1, 2020, the district held 24 meetings representing all stakeholders to discuss and plan for the 2020-21 School Year while in the COVID-19 pandemic. The overwhelming response from community members is that the district should provide in-person instruction as soon as possible with the flexibility of turning into distance learning immediately if mandated by the state and/or County Health Department. At the same time, the district also provided effective virtual classroom programs to students who opted not to return to school in person. To that end, the district re-opened its schools and brought back our students with identified disabilities at all levels as early as September 2020, followed by elementary students on October 12, 2020 and Crocker students on November 16, 2020. The district hired additional teachers and re-assigned specialist positions as classroom teachers to significantly reduce class sizes and build small cohorts during COVID-19. In addition, the district rented portable restrooms and washing stations on campus, purchased an air filter for each learning and work space, and significantly increased the cleaning and disinfection of facilities and the purchase of cleaning supplies to protect the health and safety of our students and staff during the pandemic. To mitigate learning loss, in 2021-22 the district also purchased Greenfield Learning Tool, an online curriculum for K-5 Lexia and Newsela for district wide English Language Arts. The district is also planning to provide intervention on math by possibly providing some evidence-based high dosage tutoring as well as buying the necessary supplies.
