2. Regular Reports

2.1. Hillsborough Teachers Association (HTA)

2.5. Superintendent Report

Superintendent Louann Carlomagno thanked West parent, Dr. Pakdaman, and Director Maureen Sullivan for coordinating the district's vaccination clinics including the parent volunteers and Trustee Oliff who devoted their time to help make it run smoothly. Superintendent Carlomagno reported an update on the Omicron virus received from the county including booster shots, gatherings, holiday travel and BinaxNOW home testing for the district. She reported on universal transitional kindergarten and full-day kindergarten registration. She shared that she and the Governance team attended the California School Boards Association Conference and it was a very valuable experience. She shared Trustee Dannis was an excellent facilitator for one of the sessions and is proud of what their team brings to the table. Superintendent Carlomagno reported a food services update that Chief Business Official Joyce Shen has been working proactively with food programs for the district. She concluded her report by reviewing the current assessed property values and is happy Hillsborough's numbers are still above the prior years.


